

## YALOVA RO-RO TERMINALİ A.Ş.

### DATA SUBJECT APPLICATION FORM

#### 1. GENERAL INFORMATION

Pursuant to the Turkish Personal Data Protection Law No. 6698 ("Law" or "KVKK"), individuals whose personal data are processed ("Data Subjects") or their duly authorized legal representatives ("Applicant") are granted the right to submit requests regarding the processing of their personal data within the scope of Article 11 of the Law.

In accordance with Article 13/1 of the Law, applications related to these rights must be submitted to the data controller, Yalova Ro-Ro Terminali A.Ş. ("Yalova Ro-Ro Terminali" or the "Company"), in writing or through other methods determined by the Personal Data Protection Board ("Board").

Depending on the nature of the request, applications will be concluded as soon as possible and, in any case, no later than thirty (30) days from the date on which the application is received by the Company. If the completion of the request requires an additional cost, a fee may be charged in accordance with Article 7 of the Communiqué on the Principles and Procedures for Application to the Data Controller.

#### 2. METHODS OF APPLICATION

- **Application by Post or In Person:**

The Applicant may submit a duly completed and signed application form together with documents verifying their identity, either in person or by post, to the following address:

- **Application via Registered Electronic Mail (KEP):**

The Applicant may submit the application by signing it with a secure electronic signature as defined under the Electronic Signature Law No. 5070 and sending it to the following Registered Electronic Mail (KEP) address:

For the purpose of ensuring the timely and effective handling of the application, it is recommended

that the envelope or the subject line of the electronic mail clearly states "Personal Data Protection Law Information / Amendment Request."

In addition, applications may be submitted through a notary public or by other legally valid methods that enable identity verification. Compliance with the procedures outlined above, to the extent permitted by the chosen application method, is recommended, as it increases the likelihood of a prompt and effective response.
